Upon receipt of your deposit and this signed agreement, your reservation will be confirmed. All cancellations or changes must be made at least 24 hours from Signing this Wedding Contract or else deposit will be forfeited. Balance due is to be paid on date service is provided at the first pick up location in cash. In case rental goes beyond the set hourly package, overtime charges will then be assessed. The overtime charges will be collected when we drop party at reception. Only cash will be accepted. No checks, credit cards, or money orders will be accepted on the day of your event.

Danny K's Limousine Service, its agents, associates and sub contractors, shall not be liable or responsible for damages, loss, delay or omissions due to fire, theft, weather conditions, traffic situations, power failures, strikes, human error, acts of God, church regulations, mechanical problems, time and date errors, or any other causes arising from circumstances beyond the control of Danny K's Limousine Services. If, on the date of scheduled event the requested vehicle(s) are unavailable for reasons beyond our control you will be notified and a substitute vehicle(s) will be offered. If you do not want the substitute vehicle, you agree to cancel the vehicle, with out any cost to you. If you left a deposit on the vehicle; you will be refunded the deposit for that vehicle.

Liquor "is not" provided by limousine service. Only beer and champagne may be supplied by signer of contract. Signer also accepts all responsibility and liability for any one that is hurt, gets sick, or damages any part of the limousine while consuming liquor during the limousine rental period. Signer also agrees and sees that no minors will consume liquor in or around limousine during the rental period. At the signer's request, a gift of complimentary champagne will be added to each limousine (1 bottle per vehicle) as long as no minors will consume the champagne. Complimentary soda, water, and ice are supplied by limousine service.

There will be no stops of any kind, other than what is on the front of this contract. Only for emergencies will we make other stops.

Bride and Groom accepts all responsibility for the entire bridal party and or whom ever would travel in the limousine during the rental period. Any damage to the vehicle due to carelessness, or unnecessary roughness will be the sole responsibility of the bride and groom. It is up to the bride and groom to inform the entire bridal party of these rules and regulations. All limousines must comply with all state and federal regulations regarding child safety seats. It is up to the signee to supply limousine service with child seat. Most limousines only have one, 3 point safety belts to properly hold the seat correctly. Cash only will be collected on the day the limousines have been reserved for you. Balance will be collected at time of 1st pick-up.

**Cancellations:**

1. Customer has the right to Cancel this Wedding Contract within 24 hours of signing this contract Without Forfeiting the Deposit , No Deposit Will Be Refunded.
2. Customer has 60 days prior to wedding date to cancel any or all vehicles reserved.
3. Customer will be responsible for entire price of vehicle(s) if cancelled within 60 days of wedding date
